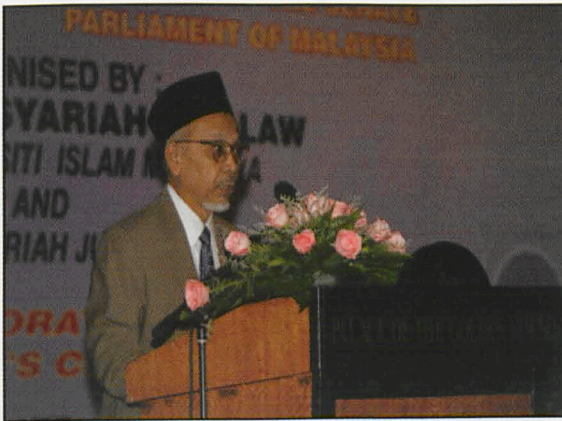

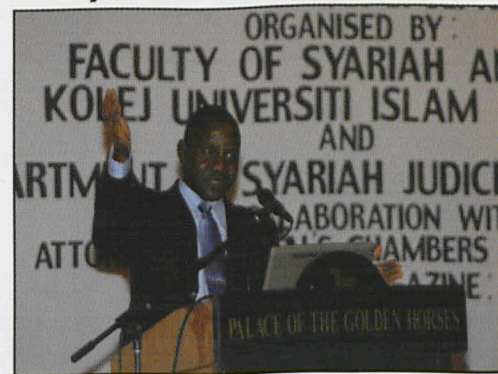

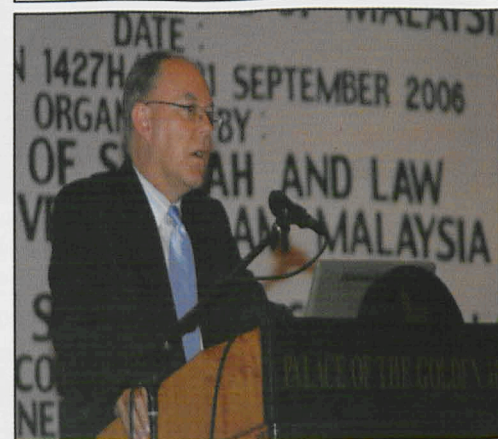
FROM FRONT PAGE - INTERNATIONAL SEMINAR ON SYARIAH AND COMMON LAW (ISCOL2006)

Among the invited guest speakers were Prof. Dr. Christa Roodt from the Department of Jurisprudence, University of South Africa, who talked about ‘Legal Pluralism in South Africa: Reflections on Common Law in the Context of Islamic Law’ and Prof. Dr. Andrew J. Harding from the University of Victoria, Canada, who presented on ‘Legal Pluralism and Religion in Historical and Comparative Perspective’. Prof. Dr. Mashood A. Baderin from Brunel University, United Kingdom expressed his opinion about ‘Concept of Human Rights under Syariah and Common Law: Scope and Limits’ and Y.A.A Datuk Sheikh Ghazali Abdul Rahman the Director of the Department of Syariah Judiciary Malaysia shared his experience under the topic entitled ‘The Future of Syariah Courts in Malaysia: Challenges and Strategies in the Pluralistic Society. Y. Bhg. Dato’ Zawawi Mohd. Saleh, Attorney General’s Chambers of Malaysia delivered a talk on ‘Interaction and Harmonisation between Syariah and Common Law: Towards Malaysian Common Law’ and Y.A Dato’ Abdul Hamid Mohamad, Federal Court Judge of Malaysia presented about ‘Conflict of Syariah and Civil Law: Issues and Practical Solution in Malaysia’. Last but not least, Prof. Dr. Mohammad Hashim Kamali from the International Islamic University Malaysia shared his legal knowledge on ‘Law, Commerce and Ethics: A Comparison of the Syariah and Common Law’.

There were 44 presenters from all over the world in the breakout session and 90 participants from local and international. With the theme, ‘Bridging the Gaps: Towards Better Understanding’, the organisation of this seminar is significant to provide suitable platform where scholars may share their thoughts on Syariah and Common Law. Since both legal systems are distinct from one and another, it is imperative to understand the diversity subsisting therein and further to offer any possible remedy or solution in effort to improve the relationship between them.

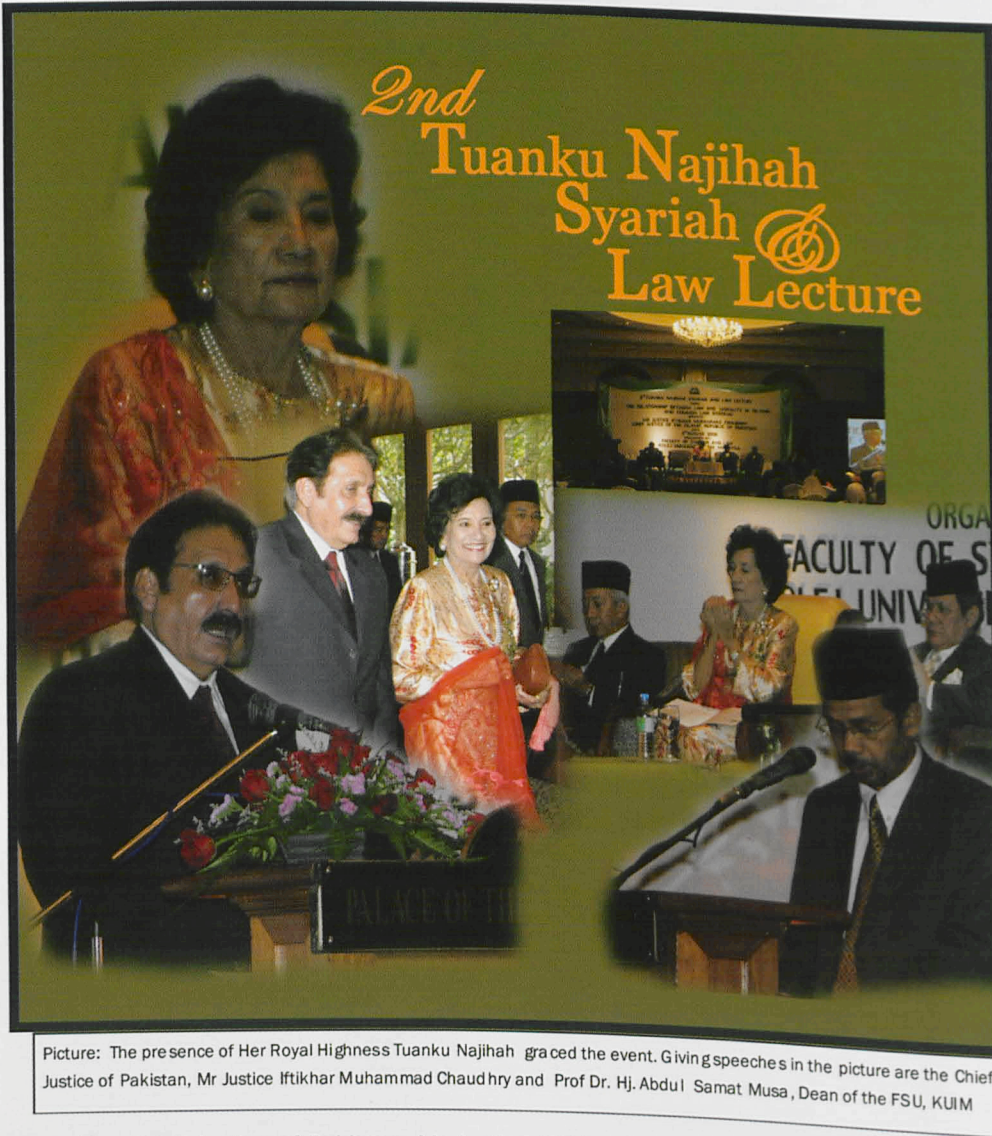

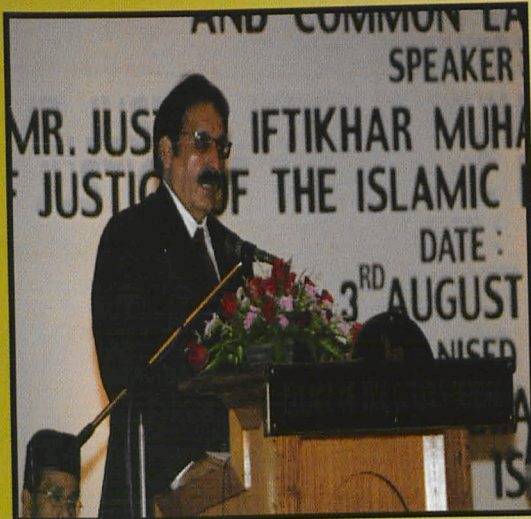
- [a] to introduce and discuss current legal issues in the field of Syariah and civil law that have relevance to the people in society;

- [c] to tap the experiences and knowledge of the speakers/scholars in the field of Syariah and civil law; and
- [d] to establish an understanding and to foster the relationship between Syariah laws and the civil laws that are practiced in Malaysia and other jurisdictions.

The Chief Justice of Pakistan, Mr Justice Iftikhar Muhammad Chaudhry, has gracefully agreed to be the speaker for the 2nd Tuanku Najihah Syariah and Law Lecture. The topic delivered by His Lordship was "The Relationship Between Law and Morality in the Islamic and Common Law System". His Lordship spoke for about an hour and a half on the topic.

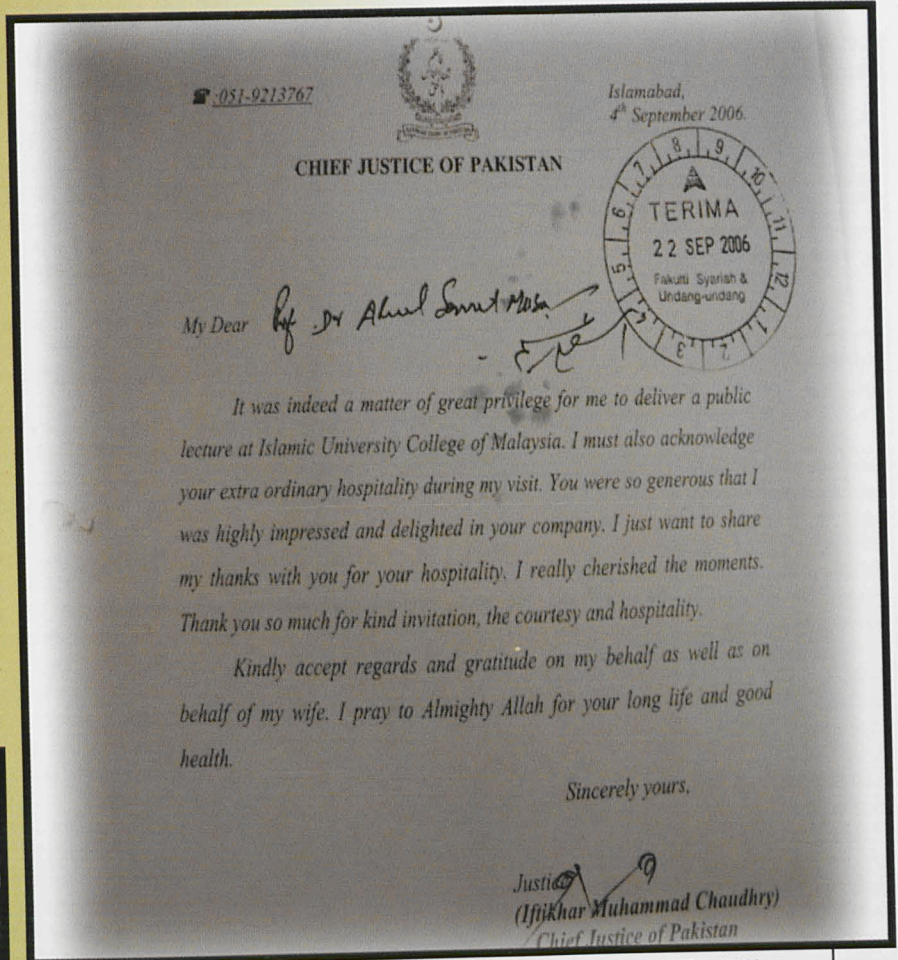

He is also lecturing in other universities at postgraduate level such as in Pasca Sarjana Universitas Islam Indonesia, Pasca Sarjana Universitas Ibnu Khaldun Bogor, Pasca Sarjana Universitas Islam Djakarta and Pasca Sarjana Institut PTIQ Jakarta. Apart from engaging in the academic field, he is also a prominent figure in various social involvements. As an acknowledgement of his work, he has been variously awarded by the country among which are the Satyalencana Karya Satya in the year 2000 and Sutra Daerah Cilegon Terbaik, Pakar Dalam Bidang Hukum Islam in 2002.

THE ADMINISTRATION OF ISLAMIC LAW IN INDONESIA

Prof.Dr.Muhammad Amin Suma, Dean, Faculty of Syariah and Law of UIN, Indonesia . (Translation by: Dina Imam Supaat)

Islamic Law Before The Proclamation of Independence

The independent state of Republic of Indonesia was formed on Friday , 17th August 1945/9 Ramadhan 1367 H. Long before the Republic was established and developed, a number of communities practicing their own legal systems exist in the whole Malays archipelago, from the magic-traditionalist community to the religion-rationalists which includes the Muslim community and their Islamic belief. Muslim sultanates were later founded among others; Pasai in Aceh; Demak Sultanate, Jepara, Tuban and Gersik in East Java; Banten Sultanate, Muslim Sultanate in Mataram and many others had implemented Islamic law in their territories.

Islamic Law During Colonial Period

During the colonial period, especially when the Dutch was in power, Islamic law was at least practiced as the living law in certain areas. The law was obeyed, practiced through the Syariah judiciary and was further developed by legal studies especially through the Islamic education boards. Thus, the condition continues until Indonesia reached its independence and moved towards better course.

Islamic Law After The Proclamation of Independence

The awareness of the Muslim ummah to practice Islamic teachings including the law generally, have grown significantly, from time to time. Even the Islamic Judiciary has undergone improvements and meaningful developments. The expansion and development of Islamic Law through education board especially in higher education have also been influential especially by the faculty of Syariah, faculty of law and the faculty of Syariah and law. To date, there hundred of faculty and programmes concentrating on the study of Islamic law in a much wider focus. Under the Religious Department of the Indonesian Republic alone, there are seven state Islamic universities, around 17 state Islamic institutes and at least 40 high schools with faculties/ programme on the study of Syariah law. Apart from that, the comprehensive Islamic law was also adapted with the current development in legal studies and regulation. The Republic is also putting more effort in codifying the Islamic law.

Currently, there are quite a number of Islamic Laws that have been codified. Among them are Islamic law covering marriage, compilation of Islamic Laws, maintenance of hajj, zakat, waqf and syariah justice.

Promulgation of Islamic Law in Indonesia

Basically, the Islamic law was enacted in the same way other laws are enacted. The process must strictly follow the procedure provided under the constitution(Undang-undang Dasara Negara Republic Indonesia 1945). The power to make laws was vested in the House of Representative (Dewan Perwakilan Rakyat). Any suggestion for new laws must be jointly debated in the House of Representative and the President for consensus. If no consensus is reached, the bill shall not be forward again to the House of Representative. The President shall consent to the bill which shall become law. In cases where the President has agreed to certain bill but later refuse to give his consent, the bill shall become law after the expiry of thirty days and it shall become effective. The House of Representative has the legislative power and the function of making budget and monitoring. The members of the House are also entitled to propose new laws. In short, the making of all laws including Islamic Law shall include joint debate and consent of the House of Representative and the President and verification by the President.

The latest development in relation to the administration of Islamic Law in Indonesia is that the process and mechanism of law making has been stipulated in an independent statute; Laws of the Republic of Indonesia No.10 of 2004 On Rules of Law Making (Undang-undang Republik Indonesia Nombor 10 Tahun 20004 Tentang Pembentukan Peraturan Perundang-undangan)

نظمت كلية الشريعة والقانون مؤتمرا عالميا لأول مرة، كانت الحلقة الدراسية العالمية عن الشريعة والقانون العام ٢٠٠٦م ((ISCOL٢٠٠٦))، والتي عقدت في فندق فيلس أوف كولدان هورس، بكوالا لمبور (PALACE OF GOLDEN HORSES HOTEL)، للفترة من ١٩-٢١ أيلول ٢٠٠٦م الماضي، وقد افتتحت من قبل تن سري داتو دكتور عبد الحميد فاونتيه، رئيس المجلس الوطني، وجرت مراسم اختتامها في اليوم التالي من قبل داتو إدريس هارون، رئيس الادعاء العام الماليزي. إن الفكرة الرئيسية لـ ((ISCOL٢٠٠٦)) هي "تجسير الفجوات نحو تفاهم أفضل". وتهدف الحلقة الدراسية لـ ISCOL٢٠٠٦ إلى :

(أ) تعزيز تفاهم أعظم بشأن القضايا الأخلاقية، مبادئ القانون وتطبيقها في الشريعة والقانون العام.

(ب) تأمين أرضية مناسبة لنشر أفكار بناءة من الخبرة الفنية للشريعة والقانون العام.

(ج) تطوير نموذج/نماذج مثالية مناسبة، أو فكرة/أفكار للتفاهم، تدرك فيها الاختلافات في الرأي والمقتربات في ظل الشريعة والقانون العام.

(د) تعزيز القانون العام الماليزي وفق المعتقد الديني، الحياة الثقافية وتقاليد المعيشة في مواجهة التحديات في المجتمع الماليزي.
